## Edna May Aucker Scholarship Trust

### Scholarship Nomination Guidelines:

For a nomination to be considered, the Nominee must be a person who has regularly participated in church, scouting or 4-H activities, who is a senior in high school and who is a resident of Snyder County, Pennsylvania. The nominee is a person who is morally, mentally, and physically competent and worthy. The nominating Pastor and nominee should not be a director, committee member, or principal officer of First National Trust Company with governing powers over the Trust, a substantial contributor to the Trust, nor be related to any of them by blood or marriage.

To retain the scholarship award for four years of undergraduate college the recipient must: be a high school graduate, attend a qualified college or nursing school, attend the undergraduate school for consecutive years without withdrawing or being expelled, maintain a minimum grade point average of 2.5, or equivalent, and not engage in any conduct unbecoming to a Christian.

### To apply for a scholarship grant:

- 1) Complete the attached nomination form.
- 2) Provide a copy of nominee's most recent high school transcript. Report should cover period from at least from 9<sup>th</sup> through 11<sup>th</sup> grade.
- 3) Submit the completed nomination form and grade report to your high school Guidance Office.

Completed application packets should be received no later than **March 31**. Applications with incomplete or missing information will not be considered.
